A Legacy of Service

Brian Cook is a dedicated volunteer fireman. He is a member of the Smithfield Volunteer Fire Company No. 1 in Huntingdon, PA. He has been called to perform many duties, some of them on the water. On 2 January 2012 Brian was called to search for the body of a 20 year old man, Julius Rodgers, who fell off the Neu Bridge in nearby Mount Union on New Year's Day. To aid in the search. Brian had cadaver dogs. He was not able to locate the body. A different team using lights located the man's body the next night.

Brian is the son of Carol (Campbell) Cook and is the grandson of P/C Ken Campbell, JN. His rescue boat was the first boat that P/C Campbell inspected this year under the Vessel Safety Check Program. According to Ken, Brian's boat is unique because it has a jet drive outboard of about 250 horse-power. This aids in shallow water operation.

Ken is justifiably proud of his grandson and his willingness to serve his community through the Volunteer Fire Company. Most likely Brian has learned that commitment to community from his grandfather and family. P/C Campbell leads our squadron's effort in the VSC program and has performed far greater than 1000 vessel examinations.



This could be made available to boaters starting in late August. The damage done by improper winterization can also cause problems that may not be apparent during the spring launch but could impact a boater's safety later in the season.
